Program Description

The Community Living Victoria Foundation is pleased to offer grants to individuals and groups who are currently supported by Community Living Victoria programs and services who have a financial need based on the criteria below. Criteria

Application for a grant is open to all Community Living Victoria participants and their families whose lives would be enhanced by a financial grant in one of these four areas:

- **HEALTH** – Addressing health concerns of individuals of families; providing access to nutrition or food access, dental needs or other medical needs, physical fitness or other proactive activities that have an impact on health or wellbeing.
- **QUALITY OF LIFE** – Mobility aids, technology or employment related items that will enhance an individual's everyday life.
- **EDUCATION** – **Assist** individuals with disabilities with furthering their education by providing financial assistance that is not already funded by government programs.
- **INCLUSION** – Projects or events supporting inclusion in the community. Projects that support individuals with intellectual disabilities or have significant impact on awareness or are community service related. Outcomes that are measurable are required.
